THE COMMISSION OF INQUIRY INTO STATE CAPTURE HEARING OF PRESIDENT, MR CYRIL RAMAPHOSA, 11-12 AUGUST 2021

The hearings of the Judicial Commission of Inquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State will hear testimony of the President of the Republic of South Africa, His Excellency, Mr Cyril Ramaphosa from 11-12 August 2021 at 9:00 AM to allow sufficient time.

Members of the media, public and special interest groups are advised that the hearing will be heard at City of Johannesburg Old Council Chamber, 158 Civic Boulevard, Braamfontein, from 11-12 August 2021. Due to the high media and public interest in the matter, media are requested to submit their names via their editors for the upcoming hearing to the Commission of Inquiry Into State Capture.

In adherence to measures to limit the spread of COVID-19, strict social distancing protocols will be observed in the media gallery and please note that there will be limited seating. In order to accommodate all hearing attendees, we request that media houses assist us by sending accreditation for **One** person only to be seated inside the hearing chamber. Special interest groups are also requested to submit accreditation requests. The information should include the individual's name, name of organisation/media house they are representing, ID number, designation, and contact details (**See attachment**). It should be noted that not all applications will be approved.

Access to the hearing chamber will be for accredited persons only. Please be advised that a very limited number of seats are allocated for accredited members of the media inside the hearing chamber. Accreditation requests should be sent to Rev Mbuyiselo Stemela, mbuyiselos@commissionsc.org.za, no later than Monday, 09 August 2021, 17h00. Notification will be conducted via email.

Photographers and **OB van personnel** are requested to submit their names, for access within the cordoned off security area around the hearing venue.

NB: Please be advised that simply submitting a name for accreditation does not guarantee approval. Please await an accreditation notification.
