
FIRSTRAND BANK LIMITED'S STATEMENT

I, the undersigned,

JOHAN PETRUS BURGER

do hereby state that:

1. I am a director of FirstRand Bank Limited ("FirstRand"). During April and May 2016, I was FirstRand's Chief Executive Officer.
2. First National Bank ("FNB") is a division of FirstRand.
3. FirstRand has been requested to provide the Judicial Commission of Enquiry into allegations of State Capture, Corruption and Fraud in the Public Sector with:
 - 3.1. All correspondence between FirstRand and the so-called Interministerial Committee ("IMC");
 - 3.2. Any minutes and other documents relating to the meeting(s) held between FirstRand and the IMC as represented by Minister Zwane relating to the closure of bank accounts; and
 - 3.3. All correspondence including notes and minutes of meetings relating to the interactions between FirstRand and the National Executive Committee of the ANC regarding the closure of bank accounts.

4. On 22 April 2016, an advisor to the Minister of Mineral Resources, who suggested that she was acting as the secretary to the IMC that had been set up, sent an email to FNB's CEO inviting him to attend a meeting with the IMC, which FNB had been advised, was set up to "look into certain allegations made against certain financial institutions". A copy of this email is attached as "FNB 1".
5. In response, I on 23 April 2016 arranged for a letter to be emailed. I attach a copy of the covering email and the letter as "FNB 2.1 and 2.2". In the letter, I requested, amongst others, details of who on behalf of the IMC would attend the meeting, what specific allegations had been levelled against FNB and the nature and scope of the IMC process.
6. The Acting Secretary to the IMC responded by email on 24 April 2016, by indicating that she was not mandated to respond to the questions. A copy of her response is attached as annexure "FNB 3".
7. Consequently I arranged for a letter to be emailed to the Acting Secretary to the IMC on 24 April 2016 to advise that FirstRand declines the invitation to attend the meeting. A copy of the covering email and letter is attached as annexures "FNB 4.1 and 4.2".
8. On 4 May 2016, I received a further invitation by email from the Acting Secretary to the IMC to meet with the IMC on 5 May 2016 at 12h30. A copy of this email is attached as "FNB 5".

9. I responded to the further invitation by email on 4 May 2016. A copy of this email is attached as annexure "FNB 6". I indicated in this email that we would meet if all the members of the IMC were present and I also made it clear that while we could discuss the regulatory framework banks are required to operate within, we could not discuss specific client matters.
10. On 4 May 2016 I received a further email from the Acting Secretary to the IMC, a copy of which is attached as annexure "FNB 7". She advised that she was not mandated to respond to the queries raised in FNB 6 and they would be brought to the attention of the IMC the next day.
11. I attach as annexures "FNB8" and "FNB9" further emails that I exchanged with the Acting Secretary to the IMC on 5 May 2016, from which the following is apparent:
 - 11.1. At 7h17, I responded to annexure FNB7 by indicating that I would await a further response, once the Acting Secretary to the IMC had the opportunity to engage with the IMC regarding my email of 4 May 2016, which is attached as annexure FNB6.
 - 11.2. At 11h15, I arranged for my personal assistant to send a further email (annexure FNB9) to the Acting Secretary to the IMC recording that in the absence of a response to my emails, we are assuming that the meeting scheduled for 5 May 2016 would not take place.
 - 11.3. At 11h28, I received an email from the Acting Secretary to the IMC which read: "I refer to the exchange of emails below."
 - 11.4. At 11h32, I arranged from my personal assistant to send a further email



- to the Acting Secretary to the IMC to enquire if I could give her a call.
12. Since I had not received confirmation that all the IMC members would be present at the meeting that FirstRand was invited to, I declined the invitation to meet on 5 May 2016.
 13. Consequently, FirstRand is not in possession of any minutes or other documents relating to meetings between FirstRand and the IMC.
 14. I cannot recall the exact date, but on either 18 or 19 April 2016, while I was out of Johannesburg at a FirstRand strategy conference, I received a telephone call from Mr Enoch Gondongwana explaining who he was and that he was in the process of setting up meetings with the bank CEOs and the Secretary-General of the ANC, with regard to the closure of client accounts. He indicated that he would get back to me to arrange a time to meet when I had availability.
 15. On 20 April 2016, shortly after 10h00, I received an SMS from Mr Gondongwana requesting me to call him. I responded by SMS to point out that I was about to board a plane and I enquired if I could phone him later that afternoon. He responded by SMS with a "yes".
 16. In the afternoon of 20 April 2016, I called Mr Gondongwana. He indicated to me that he was following up on my availability to meet. I advised him that I was not in Johannesburg, and would only be available to attend a meeting with the ANC Secretary General, at Luthuli House on the 22 April 2016.
 17. On 21 April 2016, at 13h13, I sent an SMS to Mr Gondongwana to enquire who would be attending the meeting and what the agenda for the meeting was



so that I could prepare for the meeting.

18. I had not received a response and at 18h27, I sent a further SMS to Mr Gondongwana to enquire whether the meeting scheduled for 22 April 2016 was still on. He responded by SMS to indicate that the meeting was off.
19. FirstRand did not meet with the National Executive Committee of the ANC regarding the closure of bank accounts and is not in possession of correspondence and minutes of meetings between FirstRand and the National Executive Committee of the ANC regarding the closure of bank accounts.
