SUPPLEMENTARY STATEMENT

I, the undersigned,

ROY JANKIELSOHN

do hereby state that:

- 1. I have already submitted a statement to the Judicial Commission of Inquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State (the "Commission") on 29 April 2019.
- 2. The facts contained within this supplementary statement are both true and correct, and within my personal knowledge, unless the context provides otherwise. Where facts were provided by third parties, they are presented in the belief that they are true and correct.
- 3. The purpose of this supplementary affidavit is to correct errors in my signed main statement and to introduce documents relevant to my testimony that do not currently form part of the bundle which will be referred to in my testimony.
- 4. For ease of reference, I will identify the specific paragraph and line in the statement to which the corrections are to be effected and I will set out the nature of the corrections or annexures to the supplementary statement to which the documents relate.

5. Ad paragraph 13:

The last sentence referenced "A copy of the Mail and Guardian articles are attached hereto as annexures RJ1 and RJ2" to be deleted in its entirety and substituted with the sentence to read "A copy of the SOPA and Mail and Guardian articles are attached hereto as annexures RJ1 and RJ2".

6. Ad paragraph 18.24:

At line 2 that, reference to "April 2016" to be corrected to read "August 2014".

7. Ad paragraph 18.26:

At line 2 that, reference to "April 2016" to be corrected to read "August 2014".



8. Ad paragraph 18.28:

The whole paragraph be deleted in its entirety and substituted with the paragraph to read "In reply dated 28 April 2015 to a question to the MEC for the DARD regarding whether disciplinary action was instituted against the senior officials as recommended in the National Treasury report, the Acting MEC for the DARD Ms O. Mlamleli indicated that no disciplinary action was instituted, which indicates further that the report was deliberately ignored. I attach hereto as annexure "RJ16" a copy of said reply."

9. Ad paragraph 18.56:

The sentence referenced "This is all I wish to record at this stage" to be deleted in its entirety and substituted with the sentence to read "I further wish to place on record that in a reply to the Public Protector as indicated in her report attached as annexure RJ25, former Premier Ace Magashule indicated the following:

We are also advised that a Guesthouse, which was procured in the town of Vrede to accommodate individuals responsible for the implementation of the project, is included in the amount of R2,6 million. It was necessary to buy this property, given the fact that there were no facilities in existence on the land in question at the commencement of the project. The Premier further committed to an assessment of value for money to be performed by the Free State Provincial Treasury".

10. Ad paragraph 18.57:

For further background and context I attach the following document attached hereto as annexure "RJ26" that proves that the guesthouse is currently owned by a Mr Prasad Chadrama, who purchased it from Estina (Pty) for an amount of R1,35 million in 2016 from Estina (Pty) Ltd. Estina (Pty) Ltd purchased this property in 2012 for R1,2 million which implies that public funds were used to purchase a private property which Ace Magashule must have been aware of. This also implies that the current very elementary security gate and guard house were constructed at a cost of R1,4 million.
