### SUPPLEMENTARY AFFIDAVIT

I, the undersigned,

### **KOBUS DEMEYER ROELOFSE**

do hereby state under oath that:

- 1. I am a Colonel in the South African Police Service ("SAPS") and employed at the Directorate for Priority Crimes Investigations (the "DPCI"), Western Cape.
- 2. All facts stated herein are, unless the context indicates otherwise, within my own personal knowledge and are to the best of my belief both true and correct. I give this evidence freely and voluntarily. I have not been offered any incentive or reward to depose to this affidavit.
- 3. On 23 August 2019, I deposed to an affidavit which I provided to the Judicial Commission of Inquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State ["my main affidavit"].
- 4. The purpose of this supplementary affidavit is to attach a table that I compiled of the true identity of the individuals who are mentioned in my main affidavit by way of a number preceded by the letters "FM" ("the individuals"). The table is attached hereto as Annexure "KDR.2A".
- 5. My identification of the individuals is informed by (1) their recruitment as an agent or as a source in the records of the Crime Intelligence Division of the South African Police Service; (2) the probabilities that disclosure of the identity of the individuals in the public domain will jeopardise their personal safety and the covert operations that they may have been involved in. There is however no certainty of which individuals are still involved in covert operations, if at all. It is my considered view that it is neither in the interest of the individuals'

personal safety and security nor the public interest for the true identities to be made public in any way whatsoever.

6. Accordingly, I humbly request that **Annexure "KDR.2A"** not be made available for public consumption in any respect. This list is placed in sealed evidence bag PAD000573501.

I know and understand the contents of this declaration.

I have no objection to take the prescribed Oath.

I consider the oath to be binding on my conscience.
