#### **AFFIDAVIT**

I, the undersigned,

#### Ronald Shingange

do hereby state under oath:

- 1. The facts deposed to herein are true and correct and are, save where the context indicates otherwise, within my personal knowledge.
- 2. This affidavit is submitted for purposes of providing evidence to the Commission of Inquiry into State Capture ("the Commission").
- 3. I am an adult male 5 years of age, residing in the Polokwane area.

#### **Employment history**

- I was previously employed in Government and in the private sector from the year
   1994 onwards, as follows:
  - 4.1. 2000: Chief Director at the Public Works Department ("PWD");
  - 4.2. 2001; Deputy Director General ("DDG") at PWD;
  - 4.3. 2002 2005: Acting Head of Department at PWD;
  - 4.4. 2005 2006: Economic Development;
  - 4.5. 2006 2009: Chief Executive Officer at Corridor Mining Resources;
  - 4.6. 2009 to early 2013: Advisor to Minister Chabane at the Office of the Presidency;
  - 4.7. Early 2013 to October 2014: Private sector;
  - 4.8. October 2014: re-joined Minister Chabane at the DPSA until Minister Chabane's death in March 2015.

#### Mr Themba Maseko

- 5. With regards to the removal of Mr Themba Maseko ("Mr Maseko") from Government Communications and Information Systems ("GCIS") and replacing him with Mr Manvi:
  - 5.1. I was the Advisor to Minister Chabane at the time during February 2011;
  - 5.2. Minister Chabane would normally request my advice on Government policy development and implementation as well as certain economic related aspects;
  - 5.3. Prior to February 2011 and subsequent to Mr Jacob Zuma becoming President of South Africa in May 2009, numerous Director General's and DDG's were moved from their positions;
  - 5.4. Prior to the replacement of Mr Maseko as DG of GCIS with Mr Manyi,

    Minister Chabane did not discuss the matter with me;
  - 5.5. Approximately two weeks or so after the move of Mr Maseko to DPSA had been announced, whilst I was going into a meeting with Minister Chabane, I asked Minister Chabane 'why Themba was being moved'.

    Minister Chabane replied that he had been 'instructed to move Themba';
  - 5.6. I did not ask further about this at the time as we were going into the meeting; however, I understood from this, that the instruction must have come from the former president, Mr Zuma, as he, Mr Zuma, was:
    - 5.6.1. The only person in a position to instruct Minister Chabane; and
    - 5.6.2. Mr Zuma was the only person with the power to 'approve' movements of DG's.
  - 5.7. In retrospect, I should have asked for further details from Minister Chabane:
  - 5.8. To my understanding, Minister Chabane's relationship with Mr Zuma was good at the time.
- 6. Subsequent to the testimony of Mr Zuma before the Commission:



- 6.1. I have been contacted by various individuals who expressed their displeasure at the statement by Mr Zuma that Minister Chabane may have used the Presidents name in vain or to achieve his own ends;
- 6.2. I agree with the sentiments expressed publically by others that it was not in Minister Chabane's nature to have used the Presidents name or position, if this was not the true and correct position.

I know and understand the contents of this affidavit.

I have no objection in taking the prescribe oath.

I consider the prescribed oath to be binding on my conscience.
