hereby declare under oath as follows:

- I am an adult female and previously employed by the South African Broadcasting Corporation (SABC) as a Journalist.
- The contents of this affidavit are true and correct and falls within my own personal knowledge, unless the contrary clearly appears from the context or is otherwise stated.
- I have been approached by investigators associated with the Commission of Inquiry into Allegations of State Capture, Fraud and Corruption in the Public Sector and certain Organs of State ("the Commission") and have been requested to confirm the coverage by the SABC of the Women's day celebrations of 9 August 2013, which took place at Bushbuckridge, Mpumalanga. The investigators provided me with a short news clipping and a link to the full event video and requested that I confirm the identity of the female reporter that provided the English coverage of the event.
